# Constable Ryan Reinhold

In this issue we are going to profile a hard working Constable and a person that goes the extra distance to serve his fellow Constables, Ryan Reinhold.

Ryan has been serving as Constable in Navajo County Precinct 6 since 2003, but this is actually his second time serving, as he was also elected Constable in 1976. He filled the time between his terms as Constable, serving as Justice of the Peace in Navajo County for 22 years. A native Arizonan, born in Phoenix, Ryan has been married since 1976, and has 2 children. Ryan's accomplishments have been many; for one thing, he has sat as Judge in 23 different courts. Constable Reinhold is considered an expert in many arenas of the Justice system and has taught at the National Judicial College, the Institute of Court Management, and Arizona Judicial College. His accomplishments go on but there is insufficient room on the page to list them all.

From the time that Ryan became Constable he has been active in our Association. Serving on the Board has allowed Ryan to lend his knowledge and experience in order to further Association Goals and to give a different to discussions on Association perspective business. # Firearms Training Officer Safety

The Constable's Association just concluded a successful five day Basic Firearms Academy held from April 4-8, 2011. This academy was made possible by a grant from the Constable Ethics Standards and Training Board written by ACA President Constable Phil Hazlett.

A total of 21 Constables from throughout the state attended this training. The training was conducted by AZ POST certified firearms instructors Constables Ron Myers, Vince Roberts, John Nozar, Deputy Constable Brent McCleve And safety officers Constables Phil Hazlett, Dan Ryan and Deputy Constable Tony Martineau. This is the same course all police recruits are required to successfully complete to graduate from the police academy.

The course called for a minimum of 1200 rounds to be fired during the training. Because it was a 50 hour course, we ran it for at least 10 hours each day. The range was the Joe Foss Range located in Buckeye Hills, AZ which is about 10.5 miles south of Interstate 10 on the way to Gila Bend.

The Association paid per diem and lodging for those attending from outside Maricopa County. Members were place in the Comfort Inn and Suites in Goodyear which was about 25 miles from the range. It was the nicest hotel we could locate near the facility. Needless to say we had long days with long drives, especially for the people from Maricopa County who commuted each day, some driving over 50 miles each way. It was a good class considering that on two of the days, we had winds gusting over 30 mph blowing sand in our faces. That made for a challenging shoot.

The majority of the shooters accomplished required passing scores on both day and night qualifications. Everyone who attended will receive a certificate showing 50 hours of training which will need to be filed with the Ethics Board as required for all training records. By Constable Ron Myers Sometimes we have to be reminded again about officer safety as we conduct our jobs as Constables. Much of what we do is routine and it is easy to get into the mode that this is just another eviction or just another summons. We should never think like that as it takes just one irrational person to change our whole life. Recently Constable Kevin Jones and Reserve Deputy Constable Rick Harris went to a trailer to evict a tenant. Constable Jones had posted the residence the day before and given him 24 hours to vacate. They were supposed to be back at 8:00am the next day.

They learned that the tenant had asked the court if Constables carry guns. That should be enough to make the hair on anyone's neck stand up. They didn't arrive at 8:00am but came about two and a half hours later. When they approached the residence, they saw some things that made them step back and call the Sheriff's Office for backup. Deputies entered the trailer and found the defendant dead of a self-inflicted gunshot wound.

Had he been planning to shoot them at 8:00am and got tired of waiting or had he planned a "suicide by cop"? We will never know but this is one more example of always being prepared, aware and not being complacent. It would just as easy for a defendant to shoot one of us first before taking his/her own life. Stay smart and come home to your loved ones when done for the day. # **CONSTABLE LEGISLATION**

This last year was a successful year for Constables in the Arizona Legislature. We had three bills introduced on behalf of the ACA. Two of the bills passed the legislature and were signed by the Governor and will become law on the 15th of July. The third bill, Hb2067 was vetoed by the Governor after an amendment was attached concerning the Arizona Board of Regents.

HB2068 Constable Salaries ARS 11-424.01 add the changes B and C and now reads:

B. IN PRECINCTS WITH AN AVERAGE OF ONE HUNDRED OR FEWER TOTAL DOCUMENTS SERVED PER YEAR BY A CONSTABLE OVER THE PREVIOUS FOUR YEARS, A CONSTABLE IS ENTITLED TO RECEIVE AN ANNUAL SALARY OF NOT MORE THAN FIFTEEN THOUSAND DOLLARS.

### **B**. C. IN PRECINCTS WITH AN AVERAGE OF MORE THAN ONE HUNDRED TOTAL DOCUMENTS SERVED PER YEAR BY A CONSTABLE OVER THE PREVIOUS FOUR YEARS,

SB1600 (which became SB1200) Constable Duties and Fees ARS 11-445, 22-131 and 28-1525 The sections that have changed for us are:

11-445. Fees chargeable in civil actions by sheriffs, constables and private process servers; authority of private process servers; background investigation; constables' logs

L. If the sheriff or constable serves a warrant issued by a justice or superior court judge for failure to pay a fine, the court shall collect a ten per cent surcharge on the amount of the fine owed by the defendant and shall transmit the monies collected to the county treasurer for deposit in the county general fund.

### 22-131. Constables; powers and duties

A. Constables shall attend the courts of justices of the peace within their precincts when required, and within their counties execute, serve and return all processes, WARRANTS and notices directed or delivered to them by a justice of the peace of the county or by competent authority. In addition to any other provision of law these duties may be enforced by the presiding judge of the superior court in the county, including the use of the power of contempt.

### 28-1525. Assessment; failure to pay fine

IN ADDITION TO ANY FINE, FEE, PENALTY OR ASSESSMENT AUTHORIZED BY LAW, A PERSON WHO IS CONVICTED IN THE SUPERIOR COURT OR A JUSTICE COURT FOR A VIOLATION OF THIS TITLE SHALL PAY AN ASSESSMENT OF ONE HUNDRED TWENTY-FIVE DOLLARS IF A WARRANT FOR FAILURE TO PAY A FINE, FEE, PENALTY OR ASSESSMENT IMPOSED AS A RESULT OF THE CONVICTION IS ISSUED FOR THE ARREST OF THE DEFENDANT. THE COURT SHALL TRANSMIT THE ASSESSED MONIES TO THE COUNTY TREASURER FOR DEPOSIT IN THE COUNTY GENERAL FUND. THE ASSESSMENT IS NOT SUBJECT TO ANY SURCHARGE.
